## **DRILLING FOR URANIUM IN SOUTH AUSTRALIA**

Western Plains Gold Ltd is pleased to advise that it has let a contract for a program of systematic bedrock RAB drilling for the Kalabity project located near Olary in the Curnamona Province of South Australia. The drilling is designed to further test two calcrete uranium anomalies defined from a recently completed regional calcrete survey that covered the entire 148 sq km area of EL 3297. The wide-spaced regional calcrete sampling also defined several significant gold and base metal anomalies that will be followed up with infill sampling to better define RAB drilling targets during April.


One of the anomalous uranium targets is situated along strike from the KR4 prospect where thin davidite bearing veins occur over a strike length of two kilometres. A selected bulk sample collected from outcrop of this material assayed 3.46% uranium, 1.75% cerium and 2.75% lanthanum.

Kalabity is a joint venture project with PlatSearch NL. The tenement is prospective for vein style uranium deposits in Proterozoic basement rocks. The area has been covered previously by airborne radiometric surveys but widespread alluvium may have masked the radiometric response from uranium mineralisation in the underlying rocks. The location of the project area in relation to other uranium mines and prospects in South Australia is shown in the accompanying map.
