

WPG adds to its iron ore tenement portfolio south of Coober Pedy in SA

Western Plains Resources Ltd (ASX:WPG) has extended its iron ore tenement holdings in the prospective Coober Pedy region of South Australia with the application for a new exploration licence. ELA 117/09 covers an area of 233 square kilometres and is located immediately to the north west of the magnetite-copper-gold deposit being developed at Cairn Hill. Tenements in which the Company now has an interest are shown in the drawing below.



The new tenement encompasses a zone of complex magnetic character, some of which indicates potential for banded iron formation (BIF). It includes the Mt Brady prospect where drilling by previous explorers has intersected intervals of massive magnetite including 5.8 metres averaging 61.9% Fe and 6.5 metres averaging 61.1% Fe in separate drill holes.

Anomalous copper and rare earth element intervals were also recorded in previous drilling. The Mt Brady mineralisation is reported to be associated with a sequence of pegmatite bearing skarns.

When granted, ELA 117/09 will enhance WPG's strong ground position that covers a total area of 2,061.5 square kilometres in the emerging Mt Woods iron ore province of the northern Gawler Craton. These tenements include projects with established resources that WPG is advancing towards development at Peculiar Knob and Hawks Nest and exploration projects at Commonwealth Hill where the Company is farming into tenements held by Apollo Minerals Ltd. The current tenement position is listed in the table below.
